Any and all balances are subject to late fees. Late fee policy \$15.00 late fee applies to any and all weekly and/or payment fee schedule if full balances are not received on or before agree upon due date.

Any and all balances carried forth after the close of the summer school session are subject to a \$50.00 accounting fee. Transcripts and credits will not be released to the home school if any balances remain after August 5th.

Verbal Warning/Unlimited Fines-Imposed per the discretion of the Director.

Probation.

Probation means special status with conditions imposed for a defined period of time and includes the probability of more severe disciplinary actions.

Confiscation

Confiscation means confiscation of goods used or possessed in violation of St. Patrick Summer Evening academy regulations or confiscation of falsified identification or identification wrongly used.

Restitution

Restitution means making compensation for loss, injury, or damage.

Suspension

Expulsion

Expulsion means the permanent separation of the student from St. Patrick Summer Evening Academy. Withholding of Transcripts or Report Card without refund.
